Plans to expand our League and change our name to the League of Women Voters of Hilton Head Island/Bluffton Area have given the Membership Recruitment team an excellent opportunity for publicity. The team targeted the March 9 public meeting with the Mayor of the Town of Bluffton as a chance to spread the word about our expansion and to draw in potential new members from the Bluffton area. Letters of invitation to the meeting and flyers were mailed to a selected group of Bluffton residents, and personal contacts were made by

League members. In addition to the usual newspaper announcements, flyers were emailed to both the Democratic and Republican Party membership lists. Approximately 60 people attended the meeting with Mayor Lisa Sulka, which was held in the Hampton Hall Community Clubhouse in Bluffton. Members of the membership team worked to welcome visitors and engage them in conversation about the League. Mayor Sulka's presentation and the following question period

were lively. There seemed to be strong interest in the kind of community involvement the League does so well. Team members are now planning the follow-up to encourage those who attended the Bluffton meeting as well as other Hilton Head residents and "friends across the bridge" to join us for the April Mitchellville meeting. Our hope is that the next step will involve joining us in League.

Public Meetings

1. State Senate, House, and Congressional districts are redrawn every ten years after the census is taken. The South Carolina Senate Redistricting Subcommittee has scheduled ten public hearings at various locations in the State. The purpose of the hearings is to receive testimony and gather information about how people see the areas in which they live and what factors need to be considered when the Senate districts are redrawn and the Congressional districts are redrawn to add a seventh district.

The one near us will be 6:30 to 8:30 pm on Monday, March 28, at Technical College of the Low Country in Beaufort.

Senator Tom Davis will hold a "Talk to Tom" forum at 6:30 pm April 7 in the Beaufort City Council Chambers. A question and answer session will follow a presentation by Davis about issues being considered by the state legislature.

BYLAWS
ARTICLE I

Sec. 1. Name. The name of this organization shall be the League of Women Voters of Hilton Head Island/Bluffton Area. This local League is an integral part of the League of Women Voters of the United States and the League of Women Voters of South Carolina.

Following discussion and on a motion duly seconded, the LWVHHI board found that such a change and the expansion underlying it were in our best interest. Members at a general meeting registered approval. The board urges adoption of this amendment.



Caroline McVitty

In 2007 my husband Arthur and I moved to Hilton Head.



Having just retired from a demanding and absorbing career as a corporate lawyer, I was seriously interested in

continuing to flex my intellectual muscles. My friend Ginny Kasey invited me to a League tea where I met the most fascinating women and men. They all seemed to have wonderful minds and

interesting perspectives on life, politics and community involvement. Better still, they often mirrored my own. I joined the League on the spot. And before I knew it, I was recruited to serve on the Board as co-secretary – a good start for a novice like me.

This was my first experience with the League, although I have always been active in civic affairs and have been a supporter of many causes and charities. In my family, my dad was one of the founders of the Democratic Party in our New Jersey community – and he was more than willing to voice his opinion on all the politics of the day. He was a local merchant and believed in a strong community and was active in many local and state civic and political organizations. As a result, I was always willing to

voice my opinion at public meetings and work diligently on various community efforts. I served as a planning commissioner and chair for many years, served on the board of my community associations, organized the first women's network in law school, served on church boards and committees, campaigned for candidates for political office – including my husband's daughter who is a state legislator in Pennsylvania.

In the League I have found wonderful friendships with people who are selfless, creative, tenacious and always inspirational. I am so proud to be counted among them.

Our March 9th Membership Meeting was a huge success thanks to the efforts of Kathy Quick, Julie Wittig, and the subcommittee on membership initiatives.



Over 60 people gathered in the meeting room at Hampton Hall to hear Mayor Lisa Sulka of Bluffton. She is a South Carolina native and long-time resident of Bluffton and her enthusiasm for the town of Bluffton and the surrounding area was on display.

After a brief history lesson and a walk through the annexation process (did you know that developers and/or property owners must request annexation and that 75% of the residents must sign the petition to the town?),

Mayor Sulka outlined the 2010 Strategic Plan. The five goals are: to celebrate the May River, maintain and increase a livable and sustainable community, maintain and improve town government excellence, upgrade infrastructure, and expand and diversify the economy. Efforts to meet the goals include neighborhood stabilization utilizing federal stimulus monies for low to moderate income neighborhoods, improvement in sewer, drainage, and source pollution control, business license procedures review, public/private partnerships, new signage and green space, and exploration of expanded opportunities for health care facilities.

Thanks to Mayor Sulka for a lively presentation and question and answer period. We look forward to hearing from her again next year.
