



From the President



Many thanks are due to your fellow League members who made November such a productive time for us. Sue Feutz, our Voter's Service Chair, organized a televised forum for the Bluffton Town Council election. Barbara Swift moderated, and we received many expressions of gratitude from citizens of the Town of Bluffton. Pamela Hollinger and the entire education committee presented us with a thought provoking and deeply detailed consensus meeting on the role of the federal government in education. We are so very lucky to have such knowledgeable women in our League.

On the national level, LWVUS President MacNamara testified in Washington on the effect of recent voting legislation passed by several states (including South Carolina).

You can access that video and another composed of LWV state representatives discussing methods to provide voter education and service under the new legislative rules at the LWVUS.org website.

At the local level, we have sent letters to the County Council Chairman expressing our support for a November 2012 referendum to authorize the borrowing of \$20 million for its land-buying and conservation program. LWVHHI/BA supports the view that the voters should be given the opportunity to make a decision on this important matter. We have not yet taken a position for or against the \$20 million dollar proposal. We have also contacted the Mayor of Hilton Head outlining our concerns and priorities in anticipation of the Town Council retreat early this

month. We have urged the Council to expand the recycling program to commercial establishments, consider a referendum on funding land acquisition, and to promote thoughtful, environmentally sensitive redevelopment plans. Report On November's Consensus Meeting On Education

At our League's November meeting, members were led by Education Committee Chair Pamela Hollinger and committee members Ann Coffin, Loretta Warden, Kathy Quirk, Niki Jordan, Karen Wessel and Fran Holt in discussing and answering the national League's fifteen consensus questions about the role of the Federal government in public education. Some questions were of a general nature, while others pertained to Common Core Standards and to Funding and Equity. Among the participants in the discussion were Beaufort County Board of Education Chair Fred Washington, who is also a League member, and Beth Fox, a newly retired Beaufort County educator who recently joined the League and the Education Committee. Recorder Caroline McVitty carefully kept track of the responses to the questions along with commentary, thereby enabling the board at a special meeting on November 16 to prepare what was then sent to LWVUS on its official consensus response form. We look forward to learning the results of this study when all the responses from throughout the nation have been compiled. Because LWVUS has discouraged local Leagues from publicizing their individual results, we are not including them in this newsletter.
