Mr. Budds' presentation will include information about the proposed 2012 county bond referendum to fund the purchase of additional lands. Mr. Harter will discuss efforts to save our rivers, and Ms. Marscher will give a historical perspective. A **question and answer period** will follow the presentation. And, yes, in case you missed it, we now

The League of Women Voters of South Carolina has joined in a comment letter to the Department of Justice regarding the Voter Photo ID Bill. A decision on the legality of certain provisions in the bill is expected in the not too distant future. Meanwhile, the LWVSC is developing a campaign to educate voters and help them obtain the photo IDs, if and when it becomes necessary. 

## Spotlight On Sally McGarry



In 1970, when I was a new resident of Montgomery County, MD, two of my neighbors invited me to go with them to a League of Women Voters meeting, with the intention of becoming members. We went and were impressed with the members and their programs and objectives. However, I was the only one of the three of us who joined! I joined, I became active in the Natural Resources Committee, and I learned the ways of the League as we prepared for a major presentation to all of the “units” on water issues and the Chesapeake Bay. The knowledge I gained from my environmental studies as a League member were of value to me as a Board mem-

ber of The Citizens Program for the Chesapeake Bay for many years and, later, when I was appointed a Commissioner of the Washington Suburban Sanitary Commission.

We don’t have “units” in this League because of our relatively small size. In a large League the size Montgomery County’s was at that time, “units” were a way of dividing the membership into groups by geographic area, by day of the week, or by time of day, to meet the needs of all members. We had a “baby-sitting unit” for mothers of young children who craved intellectual stimulation. When a

monthly presentation was to be made, the Committee responsible for the subject matter, had to program their members to cover all the units as “resource persons.” Each unit was responsible for providing a discussion leader and a recorder for these monthly meetings.

When Bob and I moved to Hilton Head Island, I searched out the League of Women Voters and discovered members who, like myself, have valued their League experience over the years and want to continue to be involved. I have enjoyed every minute.
